Islamic Reporting Initiative speaks at the UN in Geneva to discuss strategy and progress on the Sustainable Development Goals in Muslim majority countries

On Friday 5th October 2018, the Islamic Reporting Initiative (IRI) was invited to speak at a special event held at the Palais des Nations, home of the United Nations Office at Geneva (UNOG). The event was organized to celebrate the 49th anniversary of the Organisation of Islamic Cooperation (OIC) and focused on the strategic implementation of the Sustainable Development Goals (SDGs) by OIC Member States.

In his presentation, IRI Founder Daan Elffers emphasized the vast potential that can be drawn from the Islamic values shared by its members: “Achieving the SDGs will require a substantial paradigm shift across all sectors everywhere in the world. But by recognizing and strategically building on the intrinsic relationship between Islamic values and principles, and the values which underpin the SDGs, OIC countries already have a 1,400-year head start.”

Elffers made references to several scriptures in the Qur’an which specifically highlight the importance of ‘creating a world where no one is left behind’ in Islamic faith. He also presented the IRI’s recently-launched academic research project which focuses on examining the specific connections between scriptures in the Qur’an and the values which underpin the SDGs.

Founded in 1969, the OIC is the second-largest inter-governmental organization after the United Nations. The OIC has been a strong supporter of the IRI since its founding, in 2015.

In 2018 IRI was awarded the GIFA Championship Award in Sarajevo for its efforts to strategically promote the implementation of the SDGs in the Muslim world.

IRI delivers training program on Sustainable development and Global Compact related topics in Oman

In March 2018, employees of the Al Jisr Foundation in Oman completed the IRI certified training program in sustainable development. The 3-day course was held at Al Jisr's office in Muscat and included stand-alone lectures, hands-on teamwork, and project-specific workshops during which the employees examined relevant examples of best practice.

Together, the staff formed a clear strategic vision for Al Jisr's contribution to the Sustainable Development Goals and made a start on finding effective sustainable solutions for community projects in which they are involved. The organization plans to produce its first annual sustainable development report in 2019.

Mohamed Amersi, Chairman of the IRI Board of Trustees, said: "We are delighted to have certified employees of the Al Jisr Foundation in Oman for their knowledge and expertise in sustainable development. Al Jisr is widely respected for its visionary leadership and track record in the field of philanthropy, and we look forward to achieving many more milestones together in pursuit of our shared goals."

A family Zakat foundation, Al Jisr follows in the footsteps of the Prophet (Peace Be Upon Him) by focusing on strategic philanthropy initiatives which have the potential to leverage high-impact, transformative change. Specifically, the organization focuses on (emergency) healthcare and education.

IRI delivers training on Sustainable Development Goals and Global Compact related topics in Saudi Arabia

In the first week of September 2018, employees of the Saudi-based petrochemical company Petro Rabigh took part in a two-day sustainability training, which was led and certified by the Islamic Reporting Initiative (IRI). The interactive sustainability training course took part at the company's headquarters in Rabigh.

Attended by employees from a wide variety of departments, the sustainability training provided a basic introduction to sustainability, corporate social responsibility (CSR), and specific challenges and opportunities in the MENA region.

Dr Faisal Al Hothali, Head of Sustainability for Petro Rabigh, said: "We see great value in the approach of the Islamic Reporting Initiative to make sustainable development culturally relevant. Particularly as Petro Rabigh is aiming to deliver on the Saudi Vision 2030, which is in line with the Sustainable Development Goals; understanding where and how they overlap is hugely beneficial."

Ahmad Fatta, Inventory Planning Officer for Petro Rabigh, who was one of the participants, said: "The course covered a wide variety of aspects within the field of sustainability and I really built a good understanding of aspects I was not aware of. The message is clear when the presenter believes in it, which the trainer actually proved. Also, we had different workshops which made the concepts even more clearer."

IRI participates in peacebuilding forum at Oxford University

By invitation of H.E. Sheikh Dr Mohammed bin Abdul Karim Al-Issa, Secretary General of the Muslim World League in Makkah, the Islamic Reporting Initiative was invited to participate in the 2-day conference on 'Peace in the Revealed Religions' held jointly by the Muslim World League and the Oxford Centre for Islamic Studies. The peacebuilding forum took place on 11 and 12 May at the Oxford Centre for Islamic Studies, University of Oxford.

The objective of the forum was 'to bring together academics, theologians, and faith leaders from Abrahamic faith traditions to jointly explore the themes of peace, tolerance, and a good society'.

In his opening speech, Sheikh Al-Issa laid out a number of programs and initiatives aimed at strengthening society by consolidating the concept of national unity. He also called for the formation of centres and councils with the objective of facilitating dialogue between communities across all sectors.

His speech was followed by other keynote speeches from H.E. Sheikh Abdallah Bin Bayyah, President of the Forum for Promoting Peace in Muslim Societies; The Most Reverend Archbishop Kevin McDonald, Emeritus Archbishop of Southwark & Chair of the Bishops' Conference Committee for Other Faiths; Rabbi Dr Norman Solomon, Senior Associate of the Oxford Centre for Hebrew and Jewish Studies; Sir Alan Munro KCMG, Former HM Ambassador to the Kingdom of Saudi Arabia & Honorary Vice-President of the Saudi-British Society; and Dr Farhan Nizami CBE, Director of the Oxford Centre for Islamic Studies.

IRI speaks at WBCSD Leadership Program

On Friday 18th May 2018, IRI founder Drs Daan Elffers shared insights on the topic of ‘communicating sustainable development and reporting to stakeholders’ as a panellist during the 2018 Leadership Program organized by the World Business Council for Sustainable Development (WBCSD), held in partnership with Yale University.

The event took place at EY’s offices in More London Place.

The other panellists were Professor Frances Bowen (Dean, School of Business and Management, Queen Mary University of London) and Professor Richard Barker (Professor of Accounting and Academic Director of the Oxford MBA, Saïd Business School, University of Oxford).

The Leadership Program is the WBCSD’s flagship professional and leadership development program designed to provide current and future business leaders with an in-depth understanding of the sustainability challenges and opportunities that will feed into their strategic decision-making.

Prof. Dr Rodney Irwin, course director of the program, said: “We were very pleased to include a speaker from the Islamic Reporting Initiative in this year’s leadership program, as the Islamic Reporting Initiative is an exceptionally powerful example of effective communication for sustainable development. It emphasizes the important fact that while drivers and relevant implementation methods for sustainable development may vary locally, the core values which underpin the concept are practically universal.”

The WBCSD is a global, CEO-led organization of over 200 leading businesses working together to accelerate the transition to a sustainable world. Its member companies come from all business sectors and all major economies, representing a combined revenue of more than \$8.5 trillion and 19 million employees.

SDG 8: Interfaith collaboration at Lambeth Palace

On 16th March 2018, the Islamic Reporting Initiative joined the Global Sustainability Network (GSN) for a series of meetings in relation to tackling Sustainable Development Goal 8 (SDG 8) and modern slavery through technology. The meetings took place at Lambeth Palace, the official London residence of the Archbishop of Canterbury.

The Islamic Reporting Initiative has been actively involved with the GSN since last year, attending previous sessions at the Vatican and the United Nations and in Malta.

The GSN is a community and platform that is passionate and committed to delivering SDG 8 of the Sustainable Development Goals: Decent Work and Economic Growth. Dedicated GSN stakeholder groups include business, community, government, media and faith. With the personal support of Pope Francis, the faith chapter is chaired by IRI Chairman Mohamed Amersi.

Following a welcome address by GSN founders the Rt Revd Alastair Redfern, bishop of Derby, Bishop Marcelo Sánchez Sorondo, chancellor of the Pontifical Academy of Social Sciences, and philanthropist Mr Raza Jafar, discussions focused on sustainable economic growth, youth employment, successful models to help end slavery, and the supply chain.

Keynote speakers included Baroness Young of Hornsey, and Victoria Atkins MP, the Parliamentary Under Secretary of State for Crime, Safeguarding and Vulnerability and Minister for Women.

The Rt Revd Alastair Redfern presented recent developments of the Clewer Initiative, which is a Church of England project dedicated to mobilizing churches to end modern slavery in the UK and of which he is Chair. Specifically, he announced the launch of a new 'safe car wash' app which has been created to strategically engage the public in unearthing victims living in horrendous conditions throughout the UK.

The Archbishop of Canterbury, Justin Welby, has said of the Clewer Initiative: "William Wilberforce convinced his generation that slavery was a sin. That belief has not changed. The sin lies in our ignorance to its existence around us. With this in mind I am delighted that the Church of England has set up the Clewer Initiative to help dioceses detect instances of modern slavery and to provide care to its victims."

More than 200 years after the abolition of the slave trade there are still an estimated 40.3 million men, women and children trapped in modern slavery, of whom at least 13,000 potential victims in the UK alone.

ACTIONS TAKEN IN SUPPORT OF UN GLOBAL COMPACT PRINCIPLES

IRI to Participate in High-level Meeting UN General Assembly

On 27 and 28 September 2018, the Islamic Reporting Initiative (IRI) participated in the United Nations General Assembly High-level Meeting on the Global Plan of Action to Combat Trafficking in Persons, taking place at the United Nations headquarters in New York.

The General Assembly is one of the six main organs of the United Nations, the only one in which all Member States have equal representation: one nation, one vote. All 193 Member States of the United Nations are represented in this unique forum to discuss and work together on a wide array of international issues covered by the UN Charter, such as development, peace and security, international law, etc.. In September, all the Members meet in the General Assembly Hall in New York for the annual General Assembly session.

The opening plenary meeting on 27 September 2017 will feature statements by the President of the 72nd session of the General Assembly, the Secretary-General, the Executive Director of the United Nations Office on Drugs and Crime and the Special Rapporteur of the Human Rights Council on trafficking in persons, especially women and children, as well as an eminent person actively engaged in the fight against trafficking in persons and a representative of civil society.

Furthermore, the IRI has been invited to participate in two interactive panel discussions focused on the Global Plan of Action, creating effective partnerships, the review of achievements, gaps and challenges – and considering the implementation of the Sustainable Development Goals.

Currently, issues such as trafficking in persons have little to no reporting practice or standards. One of IRI goals is to develop new guidance on such complex issue and close this specific gap in supply chain-related reporting. IRI welcomes organizations interested in this specific aspect to contact us.

Mohamed Amersi, Founder and Chairman of the Amersi Foundation, and Chairman of the IRI Board of Trustees, said: “The promotion of inclusive and sustainable economic growth, employment and decent work for all (SDG 8) is a core focus area of the Amersi Foundation, whereby action against human trafficking, and indeed modern-day slavery, are essential priorities. I am delighted to enable the IRI’s participation at this high-level meeting of the UNGA, as to support further momentum and collaboration for this critical cause.”

Earlier this year, the Amersi Foundation kindly facilitated the IRI’s participation in a number of events related to the implementation of SDG 8, for example the interfaith dialogues at the Vatican and Lambeth Palace, high-profile events organized in cooperation with the President of Malta, and also the Nobel Peace Prize Laureate Kailash Satyarthi, and conferences held at Wilton Park, Windsor, the Royal Society of Arts, and the University of Oxford – to name but a few.

ACTIONS TAKEN IN SUPPORT OF UN GLOBAL COMPACT PRINCIPLES

Islamic Reporting Initiative (IRI) took part in a symposium entitled 'Mechanisms to challenge Islamophobia legally and through the media'

On 15 and 16 July the Islamic Reporting Initiative (IRI) took part in a symposium entitled 'Mechanisms to challenge Islamophobia legally and through the media'. The event was organized by the Organisation of Islamic Cooperation (OIC) and the Islamic Educational, Scientific and Cultural Organisation (ISESCO) in coordination with the Islamic Cultural Centre in London.

The meeting was held as a follow-up to the 'Media Strategy to Counter Islamophobia' prepared by the OIC General Secretariat and adopted by the 11th Islamic Conference of Information Ministers in Jeddah, KSA, on 21 December 2016.

The event was attended by about 50 media experts and civil society representatives, including academics from a number of European universities. The organising bodies addressed the challenges faced by the spread of Islamophobia from a professional, legal and human rights perspective.

How can we stop islamophobia together?

Dr Ahmad Al-Dubayan, Director General of the Islamic Cultural Centre, expressed his gratitude to the organisers for addressing such a pressing topic. He highlighted the fact that Islamophobia can take many forms and has become more widespread and versatile. Dr Mahjoub Bensaid, Head of Public Relations at ISESCO, praised institutions such as the Islamic Cultural Centre for showing the true image of Islam as a peaceful religion advocating tolerance, and Dr Maha Akeel, Head of Public Relations at the OIC, emphasised his organisation's mission in addressing concerns facing Muslims worldwide.

The three major topics discussed at the symposium were Islamophobia from the perspective of international law, Islamophobia from the perspectives of the media and legal and human rights, and how to promote mutual cooperation and understanding with civil society organisations to eradicate misconceptions regarding Islam and Muslims.

There has been an escalation of anti-Islamic activity, including violent acts and hate campaigns, in a number of European countries. These violations of human rights, an indication of the lack of tolerance within society, have demonstrated the urgent need to address stereotypes regarding Islam and Muslims in the media and to present a positive image which will favour dialogue and develop cooperation and shared values of tolerance and co-existence.

Lord Sheikh, Member of the House of Lords in London, mentioned in his speech at the symposium the social challenges facing many Muslims in the UK and the potential for mosques to diversify their activities to assist young Muslims in particular. Dr Harriet Crabtree, Executive Director of the Interfaith Network, discussed the role of interfaith activities and the provision of a platform for dialogue and inter-religious discussions to promote harmony between those of all faiths.

At the conclusion of the symposium a Collection of Recommendations and Proposals was submitted to the OIC, ISESCO and stakeholders, and the OIC and ISESCO were praised for their hard work in initiating the symposium and supporting Muslims worldwide.
